

The University of Johannesburg (UJ) FaceBook Group follows two core principles:

1. You should have control over your personal information. The UJ FaceBook Group helps you share information with your friends and people around you. You choose what information you put on the group page, including contact and personal information, pictures and email addresses.

2. You should have access to the information others want to share. There is an increasing amount of information available out there, and you may want to know what relates to you, your studies, your friends, and people around you. We want to help you easily get that information. Sharing information should be easy. And we want to provide you with the privacy tools necessary to control how and with whom you share that information.

Safe Use of The UJ FaceBook Group

- Children under 13 years old are not permitted access to The UJ FaceBook Group. In addition, parents of children 13 years and older should consider whether their child should be supervised during the child's use of the The UJ FaceBook Group site.
- Despite The UJ FaceBook Group's safety and privacy controls, The UJ FaceBook Group cannot guarantee that its site is entirely free of illegal, offensive, pornographic or otherwise inappropriate material, or that its members will not encounter inappropriate or illegal conduct from other members. Consequently, you may encounter such content and conduct.

- Where confidential complaints are made through this site reporting tool, The UJ FaceBook Group will use best efforts to remove the offending content or conduct and to warn or, as appropriate, to bar from the site those transmitting such content or engaging in such conduct within 24 hours of receiving your complaint.

The UJ FaceBook Group's Privacy Policy is designed to help you understand how we collect and use the personal information you decide to share, and help you make informed decisions when using The UJ FaceBook Group. By using or accessing The UJ FaceBook Group, you are accepting the practices described in this Privacy Policy.

The Information We Collect

When you visit The UJ FaceBook Group you provide us with some personal information which you knowingly choose to disclose as part of your Facebook profile. That information may be collected by us as well as information collected may be collected by us as you interact with our Web Site. For example we may see that there is confusion around registration or subjects and we may collect that information in order to action a change within UJ and streamline our processes in order to make your experience at UJ better.

When you use The UJ FaceBook Group, you may set up your personal profile, send messages, perform searches and queries, form topics in the forum, and transmit information through various channels. We collect this information so that we can provide you the service and offer personalized features. In most cases, we retain it so that, for instance, you can return to view prior messages you have sent or easily see your friend list.

You post User Content (as defined in the The UJ FaceBook Group Terms of Use) on the Site at your own risk. We cannot control the actions of other Users. Therefore, we cannot and do not guarantee that User Content you post on the Site will not be viewed by unauthorized persons. We are not responsible for circumvention of any privacy settings or security measures contained on the Site. You understand and acknowledge that, even after removal, copies of User Content may remain viewable in cached and archived pages or if other Users have copied or stored your User Content.

Any improper collection or misuse of information provided on The UJ FaceBook Group is a violation of the The UJ FaceBook Group Terms of Service and should be reported to us through the Contact Us page.

Children Under Age 13

The UJ FaceBook Group does not knowingly collect or solicit personal information from anyone under the age of 13 or knowingly allow such persons to join the group. If you are under 13, please do not attempt to register for The UJ FaceBook Group or send any information about yourself to us, including your name, address, telephone number, or email address. No one under age 13 may provide any personal information to or on The UJ FaceBook Group. In the event that we learn that we have collected personal information from a child under age 13 without verification of parental consent, we will delete that information as quickly as possible. If you believe that we might have any information from or about a child under 13, please contact one of the UJ group administrators.

Use of Information Obtained by The UJ FaceBook Group

When you join The UJ FaceBook Group, you will have already created your own profile and privacy settings on your Facebook profile. Your profile information, as well as your name, email and photo, are displayed to people in the group specified in your privacy settings to enable you to connect with people on The UJ FaceBook Group. We may

occasionally use your name and email address to send you notifications regarding new services offered by The UJ FaceBook Group that we think you may find valuable.

Profile information is used by The UJ FaceBook Group primarily to be presented back to and edited by you when you access the service and to be presented to others permitted to view that information.

Your name, and profile picture thumbnail will be available in search results across the The UJ FaceBook Group network and those limited pieces of information may be made available to third party search engines. This is primarily so your friends can find. The UJ FaceBook Group may send you service-related announcements from time to time through the general operation of the service.

The UJ FaceBook Group may use information in your profile without identifying you as an individual to third parties. We do this for purposes such as aggregating how many people in a network like a band or movie and personalizing advertisements and promotions so that we can provide you The UJ FaceBook Group. We believe this benefits you. You can know more about the world around you and, where there are advertisements, they're more likely to be interesting to you. For example, if you post information about your favourite movie, we might serve you an advertisement highlighting a screening of a similar one in your town. But we don't tell the movie company who you are.

Sharing Your Information with Third Parties

The UJ FaceBook Group does not provide contact information to third party marketers without your permission. We share your information with third parties only in limited circumstances where we believe such sharing is 1) reasonably necessary to offer the service, 2) legally required or, 3) permitted by you. For example:

We may provide information to service providers to help us bring you the services we offer. Specifically, we may use third parties to facilitate our business, such as to host the service at a co-location facility for servers, to send out email updates about The UJ FaceBook Group, to remove repetitive information from our user lists, In connection with these offerings and business operations, our service providers may have access to your personal information for use for a limited time in connection with these business activities. Where we utilize third parties for the processing of any personal information, we implement reasonable contractual and technical protections limiting the use of that information to the The UJ FaceBook Group-specified purposes.

We may be required to disclose user information pursuant to lawful requests, such as subpoenas or court orders, or in compliance with applicable laws. We do not reveal information until we have a good faith belief that an information request by law enforcement or private litigants meets applicable legal standards. Additionally, we may share account or other information when we believe it is necessary to comply with law, to protect our interests or property, to prevent fraud or other illegal activity perpetrated through the The UJ FaceBook Group service or using the The UJ FaceBook Group name, or to prevent imminent bodily harm. This may include sharing information with other companies, lawyers, agents or government agencies.

If the ownership of all or substantially all of the The UJ FaceBook Group business, or individual business units owned by The UJ FaceBook Group, Inc., were to change, your user information may be transferred to the new owner so the service can continue operations. In any such transfer of information, your user information would remain subject to the promises made in any pre-existing Privacy Policy.

When you use The UJ FaceBook Group, certain information you post or share with third parties (e.g., profile information), such as personal information, comments, messages, photos, or other information, may be shared with other users. All such sharing of information is done at your own risk. Please keep in mind that if you disclose personal information in your profile or when posting comments, messages, photos, or other items, this information may become publicly available.

We encourage our users to be aware when they leave our site to read the privacy statements of each and every web site that collects personally identifiable information. This Privacy Policy applies solely to information collected by The UJ FaceBook Group.

Changing or Removing Information

Access and control over most personal information on The UJ FaceBook Group is readily available through your own the profile editing tools. The UJ FaceBook Group users may modify or delete any of their profile information at any time by logging into their account. Information will be updated immediately. Removed information may persist in backup copies for a reasonable period of time but will not be generally available to members of The UJ FaceBook Group. Contact the administrator to be deregistered from the database.

Where you make use of the communication features of the service to share information with other individuals on The UJ FaceBook Group, however, (e.g., sending a personal message to another UJ FaceBook Group user) you generally cannot remove such communications.
