Fourie, Leila (PhD) (Economics)

After completing her bachelor's degree at the former Rand Afrikaans University (RAU) in 1989, and honours Cum Laude at UNISA in 2001, Ms Leila Fourie graduated with an MCom (Economics) from the University of Johannesburg (UJ) in 2011. She was awarded the Founders' Medal by the Economic Society of South Africa for best master's dissertation in Economics in the country.

Ms Fourie currently serves as Executive Director on the board of the JSE Limited and also on the JSE Clear and Strate boards. She oversees Post-Trade and Information Services at the JSE. Prior to joining the JSE, she worked at Standard Bank where she was the Managing Director of the Card Division. She is married to Toni and has two sons, Damian and Dillon.

Ms Fourie's research focused on the prevalence and nature of sovereign credit rating contagion in selected developed and emerging countries. She adopted a three-step econometric approach to establish whether sovereign ratings of countries are connected through common fundamentals and whether these ratings show evidence of increased asymmetry during times of crises compared to tranquil periods. This research contributed to a new body of knowledge by expanding studies on contagion to include sovereign credit ratings. The analysis is distinctive in that it connects three groups of countries and applies the concept of contagion to themes that are directly relevant to the complexities that the global economy currently faces. In addition, a new framework was introduced that connects sovereign credit ratings to contagion. The overarching findings indicate a unifying connection between sovereign ratings and the presence of vulnerabilities associated with common links.

Mr Clement Mulamba was born in Lubumbashi, DRC. He completed his Bachelor's degree in Economics at the University of Lubumbashi in 1999. His postgraduate studies include an Honours degree in Economics from the University of Lubumbashi in 2001 and a Masters degree in Economics from the University of Johannesburg in 2009. Mr Mulamba joined the National Treasury in 2009 as Senior Economist responsible for Local Government Finance Policy. He is married to Celine Lusamba and they have three boys, Gershom, Mark and Benjamin.

His thesis is entitled, "An analysis of municipal expenditure in South Africa". This is an empirical thesis that focuses on four interrelated sub-topics in the field of municipal finance. The first essay analyses whether community services provided by municipalities are characterised by spillover effects. Secondly, he investigates how municipalities use their budgets to react to shocks in expenditure, revenue and fiscal transfers. The focus of the third essay is on crowding-out between categories of municipal expenditure. Finally, the thesis analyses whether there was convergence or divergence of expenditure across municipalities. The thesis makes important methodological and empirical contributions in the field of municipal finance in South Africa. Municipalities in South Africa play an important role in improving the well-being of citizens through delivery of a range of essential services and the promotion of social and economic development. Beyond the academic contribution of the thesis, it also has important policy implications for improving the performance of municipalities, especially in efficiency of expenditure and service delivery.

Hobson, Ernest Guy (PhD) (Industrial Psychology)

Ernest Hobson is a registered Industrial and Organizational Psychologist. He holds an MCom (Industrial Psychology) and his work experience includes human resources, strategic management, psychometrics, consulting and labour relations.

The use of modern item response models in lieu of classical test theory models in psychological testing has increased in the recent past, which in turn has enabled the development of computer adaptive tests. Such tests hold the advantage that they adapt to the trait level of the testee, which means that a person's attributes are measured with shorter tests the content of which is chosen to be maximally relevant. In turn, adaptive testing leads to increased motivation and interest. Despite these advances few adaptive studies have ventured into the emergent field of emotional intelligence.

This candidate developed a computer adaptive test of the trait Self-control sub-scale of an emotional intelligence inventory using modern test theory. Post hoc computer adaptive simulations of a comprehensive data set were used to evaluate different item selection criteria and stopping rules.

The results showed that the shorter computer adaptive tests of Self-control yielded person measures that were almost indistinguishable from the full length static test. Different item starting and item selection strategies yielded largely similar results with no one single strategy emerging as the best.

These results lay a path for the construction of other non-cognitive adaptive tests. By applying these techniques, equivalent personality measures can be obtained with 50% or less of the items, which reduces the burden on respondents without significant loss in measurement precision.

Makka, Anoosha Monica (PhD) (Business Management)

Anoosha holds a Bachelor's degree in Business Management and Economics from Unisa, an MBA degree in International Business from Leeds University Business School in the UK and a Master's degree in Educational and Social Research from London University in the UK. Anoosha started her career in 1990 in the corporate sector where she worked for 10 years after which she moved to the public sector for 5 years. In 2007 Anoosha joined the Department of Business Management as a Senior Lecturer.

Post-1994 South Africa has introduced several public policies aimed at attracting inward foreign direct investment (FDI). However, South Africa is an under-performer in terms of attracting inward FDI in comparison to many other emerging market economies. Multinational enterprises operating in South Africa are confronted by many Corporate Social Responsibility (CSR) issues. The impact of this vast number of CSR issues in South Africa and the CSR environment in South Africa on FDI decision-making by multinational enterprises operating in the country is unknown.

Anoosha developed two research objectives and four propositions in order to investigate the effect of the national CSR environment in South Africa on inward FDI by multinational enterprises operating in the country. A mixed methods research design was applied with three phases of data collection. Data analysis included qualitative content analysis, exploratory factor analysis, correlation analysis and simple regression analysis. The empirical results indicate that there are too many CSR issues for multinational enterprises in South Africa to deal with. Education, training and skills development was identified and ranked as the most important CSR priority issue for South Africa. This study offered recommendations to social partners in South Africa regarding CSR and inward FDI.
