### **Introduction:**

This practice-orientated programme aims to introduce the underlying principles and application of corporate insolvency law and covers the administration of insolvent estates as well as an update on recent case law and legislation. The course deals, amongst other things, with relevant legal principles applicable to insolvency and winding-up; interaction between old and new legislation as well as business rescue; impeachable transactions and executory contracts; insolvency meetings, interrogations and the proof of claims; liability of directors; regulation of insolvency practitioners and an overview of the impact of cryptocurrencies on insolvency law. Although the focus is on South African law, cross-border issues arising when a company's assets and liabilities are located in multiple jurisdictions are also considered. The programme will be presented by Prof Juanitta Calitz as well as outside experts in practice, including some of the country's leading insolvency practitioners and attorneys.

### How Will You Learn?

The programme is broken down into 4 online evening lectures (6pm-8pm) as well as a Saturday morning workshop (9am -1pm) and includes a range of interactive content, including live video lectures, case studies and access to various further educational resources. All lectures will be available as recordings. The programme is presented on the Blackboard e-Learning platform. After successful registration, students will receive their personal log-in details and will gain access through the uLink portal. The programme will be presented from September- October 2022 culminating in an open book online examination at the end of the course.

Any equivalent qualification on NQF 5 level, or matric certificate on NQF Level 4.

She is a founding member of the INSOL International INSOLtech colloquium; member of the International Advisory Council of the Singapore Global Restructuring Initiative; an honorary member of SARIPA (the South African Restructuring and Insolvency Practitioners Association) and currently the chairperson of the INSOL International Academic Forum. Her research interests include insolvency law, international insolvency law and business rescue.
