Lupton, Cayle Selwyn (LLD)

Cayle Lupton obtained the degrees LLB and LLM (2018 and 2019 respectively) from the University of Johannesburg. He also obtained, in 2021, a certificate in Trade Finance Compliance from the London Institute of Banking and Finance in the United Kingdom. He was admitted as an attorney of the high court of South Africa in 2020 and certified in 2021 by the United States-based organisation, ACAMS, as an anti-money laundering specialist. Cayle is currently employed in the faculty of law at the University of Johannesburg, where he teaches at undergraduate level and guest lectures at postgraduate level. Prior to joining the faculty of law, he served as a candidate attorney at a boutique law firm in Johannesburg and before that, as an intern legal advisor at a large logistics company in the same city.

Cayle's thesis is a multi-disciplinary study that falls within the areas of banking law and international law. In his thesis, he investigates the impact of targeted financial sanctions on letters of credit and demand guarantees. The investigation is divided into three parts. The first part considers the impact of a bank's compliance with South African or domestic sanctions and the second part considers the impact of a bank's compliance with foreign sanctions. The second part is investigated with reference to the sanctions of the United States, European Union and

United Kingdom. The third part considers the problematic documentary practices that banks have or conceivably may adopt to limit their sanctions risk exposure. Ultimately, Cayle finds that by interfering with payment and reimbursement, sanctions diminish the integrity and utility of letters of credit and demand guarantees. He makes recommendations towards mitigating the impact of sanctions on these important instruments.
