**Please note:** The fee or any part thereof is not refunded or carried over to another year in respect of students who are, for any reason, not able to complete the duration of the workshops.

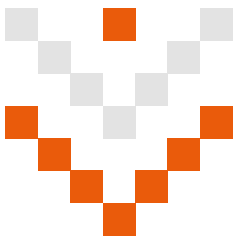
**Legal Masterclass Duration:** One to three days (dependent on topic).
