2. **Fields of study:** *intending to or pursuing an academic qualification in the built environment.*
3. **Students** *who have passed grade 12 and registered with institutions of higher learning but without a sponsor*
4. **Academic performance:** *Applicants should meet the minimum requirements for enrolling for the chosen field of study; and continuing tertiary students must have reached the requirements to progress to the next level of study.*
5. **Enrolment at academic institution:** *applicants must have already been enrolled or pursuing their studies at the relevant tertiary institution.*
6. **Financial needs:** *students from families with a combined annual household gross income of less than R600 000.00.*
7. **Demography:** *preference will be afforded students from previously disadvantage groups.*

Applicants are encouraged to join the South African Local Government Sector when they complete their studies.

COVERAGE

The MISA bursary shall cover registration, tuition, accommodation, prescribed books, other prescribed materials and meals.
